FEE STRUCTURE

As with any other non-profit association, there is an expected investment on behalf of the participating CRP to compensate for ARHE time and resources. Because of the varying nature of CRP programs, budgets, and external supports, a sliding fee scale structure is utilized. The fee scale for services related to SRCRA is listed below.

*If your program is interested in the review process, but have concerns about the fee options, please contact recovery@collegiaterecovery.org. It is our goal to make the review process as accessible as possible so that all programs have equitable access to the service.

Partial Review Bundle

Includes the Manual and Standardized Program Assessment Tool needed to complete the Internal Review. Technical Assistance may be provided by ARHE upon request during your Internal Review process.

This will be provided free of charge to ARHE Member Institutions. Non-member Institutions may consider becoming a member of ARHE to access this resource or they may pay a fee of \$250 USD to receive an Electronic Publication or PDF version of the Manual and Standardized Program Assessment Tool in order to conduct an Internal Review.

Full Review Bundle

Includes all the review elements including:

- Internal Self-Assessment Materials using the Standardized Program Assessment Tool
 - o Technical Assistance as needed during the Internal Review Process
- External Standardized Program Assessment conducted by the ARHE Review Team and Review Board
 - Standardized Summary & Recommendations Report
 - Certificate
 - Marketing Assets
 - Designation included on all ARHE communications such as the website and directory
- Follow-up meetings as requested
- 25 Hours of ongoing Technical Assistance to support the program in achieving their goals

*When determining the CRP Annual Budget, <u>do not</u> include fundraising/donation monies or grant funds.

**To qualify for a Fully Virtual Review, the ARHE Review Team and Review Board must be able to view or tour the CRP designated space on campus via pictures and/or video. If institutional policy prohibits this, a Hybrid Review MUST be scheduled. Visualization of the CRP Space is a critical component of the SRCRA process as space plays a vital role in CRP development.

***A Hybrid Review may be requested as opposed to the Fully Virtual Review or may be required as stated above. The cost includes all necessary travel arrangements for the 1-Day Site visit. ARHE will handle the booking of all travel arrangements.

<u>A completed review is good for five years</u> at which point the program should consider re-applying. *If a program receives the ARHE Developing Program designation and chooses to re-review within two years, they will only be responsible for 50% of the costs for the re-review and the new designation will be good for an additional five years.*

If a program receives a Conditional designation, they will work with the ARHE Staff to prepare for a rereview of the conditions stated in the final report within the designated time frame and will not be charged.

Additional Services:

Technical Assistance provision by ARHE Staff and/or designated representatives that will be conducted as needed and/or requested. Each program completing the review will be allocated 25 hours of Technical Assistance as part of the accreditation fee structure.
